In particular, it aims to:

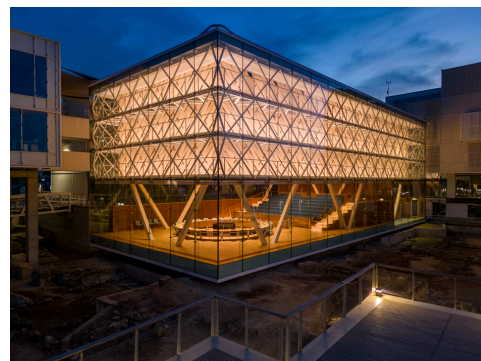
- Inform and educate the public on issues related to Jewelry, Applied Arts and Crafts as art forms and a means of creative expression.

- Bring together all interested and collaborative parties/members (artists, galleries, collectors, museums and other institutions promoting the arts and culture etc.) through communication and networking.

THE PROJECT

JELO6 Project Cyprus 2025, will take place between the 12th and 16th of November.

The central exhibition JEWELRY + OBJECTS + our 6 SENSES will be hosted by two main Venues: The Old Town Hall and the New Town hall of Nicosia. All satellite exhibitions and events will be hosted by a number of venues and cultural spaces situated all around the old part of the city.



- About the Old Town Hall.

A significant architectural landmark that reflects the rich cultural heritage of Cyprus. Built in 1930, The Old Town Hall of Nicosia is one of the most beautiful neoclassical buildings within the city walls, on the D'Avila bastion which housed the municipality from 1944 until 2016. It is centrally located next to the Eleftheria Square designed by Zaha Hadid and the contemporary Jean Nouvel apartments. Together, these urban elements create a dynamic interplay between tradition and modernity that enriches the cultural landscape of Nicosia. Very near, unfolds the bustling Laiki Geitonia area, which is known for its narrow streets, traditional houses, and enticing atmosphere.

- About the New Town Hall.

Located In the heart of the walled city of Nicosia, The New Town Hall provides a transparent interface between the civic and the public realms. Built on a symbolic site adjacent to the fenced 'green line' that crosses the island, the project gathers the formerly dispersed municipal departments into one building. This modern building settles amongst the archaeological ruins, which date back to the copper age and carry the history of the divided city.

ELIGIBILITY

The organization JELO6 Project / CYPRUS 2025 is addressed to schools, independent designers / makers, groups and galleries from all Cyprus and all countries around the world that

- consider jewelry and wearable art, ceramics, small scale sculpture and applied arts in general, as a means of self-expression, self-discovery and healing through embodiment in times of transition, and that
- through their action are trying to push the boundaries between past and future grounds, establishing bridges and interconnected practices.

We are also looking for:

authentic approaches, and excellence of craftsmanship.

Note that: there are no restrictions regarding the material, and concept of the work presented, however, size restrictions apply (please look at the "material required" included in the application section). **NO BRAND NAMES WILL BE ADMITTED TO PARTICIPATE.**

Please remember that: all works must be new and carefully selected to converse with our theme. Pieces that are part of past collections (more than two years old) or have been exhibited before will not be accepted.

Artists, Groups, Galleries and Schools that decide to apply should be ready to bring their work in person and join us at the opening/s.

ALSO PLEASE NOTE: to be eligible to participate, each of the artists (or the one that assumes the responsibility to represent their group) should be properly registered as a self-employed worker in the Social Security system or be part of a company for taxation purposes.

THE JURY

Our central exhibition: **JEWELRY + OBJECTS + our 6 SENSES** is a Juried project. All satellite exhibitions go through a selection process as well.

INDIVIDUAL ARTISTS: HOW TO APPLY FOR THE CENTRAL EXHIBITIONS OF JELO6 Project / CYPRUS. FEEL, EMBODY, CREATE. DEADLINES.

Those interested in applying should read the instructions below carefully and send all required materials via WeTransfer to the following email address: jelo6project@gmail.com

Required materials should describe one collection of work.

Specifically please send,

-Name, Address, Phone Number, E-mail, Web/Blog Address, Place and Date of Birth

-CV

-5 Photos representative of the work. Each photo should show only one piece of jewelry, photographed **on white background**. Dimensions: 10x15cm. Minimum resolution: 300 dpi. Format: JPG, JPEG. Each photo should be named as follows: Artist Name_Description_Title.jpg (JohnSmith_Brooch_UnderTheSkin.jpg).

-Captions for each of the submitted photos, describing materials used for the making of the specific pictured piece, as well as the **true dimensions** of the objects to be exhibited.

-Brief Artist Statement (120 words max) presenting the concept behind the collection, inspiration, techniques and materials used etc.

All information submitted must be original, unedited and up to date. (The work must have been produced during the last couple of years and it should not have been exhibited before in Cyprus).

Application forms must be received by **May 25th 2025. No entries past the deadline will be accepted.**

- **PARTICIPATION FEE:**

APPLICATION FEE: The application process has a non-refundable fee of **35 euros**. Follow the online directions while applying.

PARTICIPATION FEE:

To confirm your participation in JELO6 Project / CYPRUS 2025 if selected, please note that the amount of **650 euros + VAT 19%**, should be deposited to the JELO6 Project team's account.

If your application reaches us before the 1st of May, a 20% reduction will apply to the fee.

IMPORTANT: VAT is payable by everyone except those EU residents who have a tax identification number that is suitable for use in intra-Community transactions. Please use the VAT confirmation program - VIES - following the link

• **SELECTION / CRITERIA:**

Participants and applications, will be assessed by our jury according to the following criteria:

- 1) Conceptual approach, research line, coherence of work
- 2) Originality of design, composition and/or materials used
- 3) Craftsmanship and/or technical Innovation.

OBLIGATIONS OF JELO6 Projects ORGANIZERS:

JELO6 Project / CYPRUS 2025 is organized by the JELO6 Team.

The JELO6 Team is responsible for organizing, coordinating and communicating the entire event. Will be namely responsible for:

1. Ensuring, if needed, the smooth cooperation between private authorities involved.
2. Communicating/advertising of the event through print media (magazines, newspapers), radio, social media, bill boarding and journalists' private views.
3. Producing a catalogue enlisting all parts participating and a map depicting all JELO6 Cyprus Hot Spots.

At the same time JELO6 Team will be responsible for organizing and curating, communicating and launching the central group exhibitions of JELO6 Project / CYPRUS and will offer to individual artists, the opportunity to show their work in the OLD and NEW TOWN HALLS of NICOSIA.

As for the other events included in JELO6 Project / CYPRUS (eg. Solo exhibitions, gallery exhibitions, workshops, performances etc.), immediately after the selection of proposals to be submitted by groups of artists, galleries, schools, etc, the JELO6 Team could advice on or help with the selection of exhibition spaces/venues that will host the satellite JELO6 shows. There are several options: from shop/gallery windows, to alternative art spaces.

Please note: Setting-up of all the JELO6 exhibitions (**apart from the central exhibitions JEWELRY + OBJECTS + our 6 SENSES in the New and Old Townhall respectively**), **is the sole responsibility of participating individuals or teams.**

25/5/2025: application deadline

11/11/2025: delivery of all artworks on site. Completed between 10.00 and 12.00 noon (unless otherwise agreed).

12/11/2025: @17.30, our team finishes with setting up, and @19.00 we open our doors to the public.

16/11/2025: dismantling, after 19.00.

GENERAL TERMS AND CONDITIONS:

The following terms and conditions apply to exhibitors participating in JELO6 Project / CYPRUS 2025 (whether in the central exhibition or in all satellite events).

The organization reserves the right to review these terms and conditions without notice.

- **CONDITIONS TO ADMISSION**

All exhibitors must provide a complete application package by the mentioned due date. All information submitted must be true and up to date. All complete applications will be reviewed. The event holds the right to accept or decline any application. Decisions are final. The applicant accepts that once the application is selected, this contract holds valid and both parts will be held in accordance to it. All payments of the participation fee must be made by the date specified.

JELO6 Project reserves the right to correct or remove any material or product that is not suitable to the aim and conditions of the show.

JELO6 Project will not be responsible for transportation, shipment and insurance costs of exhibition pieces.

JELO6 Project, will provide security for the exhibition space where the central exhibition will be hosted. However, it is the sole responsibility of all exhibitors (participating in the central exhibitions or in any of the satellite events) to assume the risk of loss or damage. We recommend that participants insure all pieces against any theft, loss or damage that could arise during the event, including during any transportation or storage.

- **SALES AND COMISSIONS**

JELO6 Project allows the artists to sell or take special orders or commissions during the event/week, without the intervention of the organization. The organization does not manage any relation into sales or commission between artists and potential customers. The use of invoices is obligatory and has to hold the regulations. It is the duty of artists and exhibitors to comply with the regulations in case of selling while participating in the Festival. JELO6 Project

will have no claims or tax liability, thus, does not have a cash drawer or credit/debit card terminal for this purpose.

- **PHOTOGRAPHY/VIDEO:**

The participant agrees to the organization's use of photographs and/or videos of the art material provided by the artists, as well as any visual material obtained during the event, to be used in different media outlets, such as the web, catalogues, posters, magazines, short films, etc. for promotional purposes.

- **IN CASE OF CANCELLATION:**

The jury has the right to cancel any participation on the basis of false information or if the participant fails to comply with the criteria and dates specified. Cancellation of contract by the participant holds a 100% penalty of the total value of the participation fee if it is decided after payment has been deposited. Reimbursements will not be issued unless the JELO6 Project agrees in writing and responds to an exceptional case. This is also stated in our final agreements with the artists, which will be signed upon the finalization of the participants list.
